CONSTITUTION

ARTICLE III

Section 8. The Board shall have the power and the duty to fix initiation fees and annual dues and to fix rules and regulations covering the collection thereof including expulsion for non-payment.

Section 9. The Board of *Trustees* shall have the power to suspend *or* expel members by an affirmative vote of at least nine *Trustees*, for conduct unbecoming a gentleman, misbehavior, disloyalty, unsportsmanlike conduct, *or* other cause deemed sufficient by the Board which action shall be final and conclusive and from which the member affected shall be without recourse at law *or* otherwise.

ARTICLE VI
Membership

Section 1. Any individual person or couple, upon receiving an affirmative vote of at least seven (7) Trustees, at a meeting called for that purpose, may be elected to membership. The Board of Trustees may establish other requirements of admission.

Section 2. Prospective members shall be interviewed in person, by at least two (2) members of the Membership Committee. If the interviewers unanimously agree that a prospective member is eligible for membership, then such prospective member shall be considered for membership by the Board of Trustees. The club will not discriminate for reasons of race, religion, color, or gender when deciding on nominations proposed to membership in the Vermilion Yacht Club.

To the extent practicable, the interview shall take place at the prospective member's residence.

To the extent possible all prospective members shall attend at least one (1) Club social activity before his or her application is considered by the Board of Trustees.

All applications for membership must be in writing on blanks prepared by the Club and must be signed by the prospective members.

Copies of each submitted application shall be mailed by the Secretary or the Chairman of the Membership Committee to each active member of the Club at least fifteen (15) days before being submitted to the Board of Trustees for consideration. Such mailings shall include a request for comments to be made to the Chairman of the Membership Committee or any member of the Board of Trustees.

Each application for membership shall be accompanied by two (2) letters of recommendation, outlining the writers' personal knowledge of the applicant and his or her family, and qualifications for membership.

The Board of Trustees shall not elect any member unless said letters of recommendation are on file.
